Members interested in becoming members of the board are encouraged to nominate themselves for election. Once elected, each board member serves for a term of two years, and there is no limit to the number of terms that an individual may serve as member of the FGT board.

Persons seeking nomination must submit a valid candidate nomination form. To be a valid nomination, nominations are required to meet the following four (4) criteria:

1. The nominee is a grower member of FGT, or is the appointed representative of a company that is a grower member of FGT.
2. The nomination must be put forward by an individual who is a grower member of FGT, or is the appointed representative of a company that is a grower member of FGT. Self-nominations are permitted and encouraged.
3. The nomination must also be supported by a second individual who is a grower member of FGT, or is the appointed representative of a company that is a grower member of FGT.
4. The completed nomination must be received by the Returning Officer by 5:00pm on Wednesday, 30 September 2020.
