Persons seeking nomination must submit a valid candidate nomination form. To be valid a nomination is required to meet the following four (4) criteria.

1. The nominee is a financial grower member of FGT, or is the appointed representative of a company that is a financial grower member of FGT.
2. The nomination must be proposed by a financial grower member of FGT. A nominee may also be nominated by themselves.
3. The nomination must also be supported by a second individual who is a financial grower member of FGT, or is the appointed representative of a company that is a financial grower member of FGT.
4. The completed nomination must be received by the Returning Officer by 5:00pm on Thursday, 19 August 2021.
